THESE ANIMALS WERE ALL GIVEN NECESSARY VETERINARY CARE, WERE SPAYED/NEUTERED, VACCINATED, DE-WORMED AND MICRO-CHIPPED THROUGH THE SERVICES PROVIDED AT SRAS. OF THOSE OVER 1,100 ANIMALS 120 PUPPIES, 413 DOGS, 259 KITTENS, 301 CATS AND 18 SMALL ANIMALS WERE UNITED WITH NEW LOVING PERMANENT HOMES. THAT'S 1,111 ANIMALS AND COUNTLESS PEOPLE WHO HAVE BEEN POSITIVELY IMPACTED BY THE SERVICES SRAS RENDERED.
