SRAS STRIVES TO HONOR OUR DONORS' INVESTMENT THROUGH FULFILLING OUR MISSION AND THROUGH MAKING A DEEPER IMPACT FOR THE ANIMALS AND THE PEOPLE WHO LOVE THEM. OPERATIONS WAS ABLE TO TO SERVE 1,219 HOMELESS AND NEGLECTED ANIMALS. THESE ANIMALS WERE ALL GIVEN NECESSARY VETERINARY CARE, WERE SPAYED/NEUTERED, VACCINATED, AND MICRO-CHIPPED THROUGH THE SERVICES PROVIDED AT SRAS. SRAS IMPLEMENTED THE IDAHO K-9 ACADEMY PROGRAM IN 2019. THE PURPOSE OF THIS PROGRAM IS TO KEEP DOGS IN THEIR HOMES THROUGH BASIC AND BEHAVIORAL TRAINING AS WELL AS SERVICE AND THERAPY DOG TRAINING. THE PROGRAM HAS PERFORMED EVEN BETTER THAN WE COULD IMAGINE AND HAS BECOME A STRONG SERVICE TO BENEFIT THE COMMUNITY. SINCE ITS IMPLEMENTATION THE K-9 ACADEMY PROGRAM HAS TRAINED 34 SERVICE AND THERAPY DOGS FOR U.S. VETERANS AND INDIVIDUALS WITH DISABILITIES, TRAINED 239 ANIMALS FOR BEHAVIORAL MODIFICATIONS, AND OFFERED 588 SHELTER DOGS BASIC TRAINING AND BEHAVIOR MODIFICATIONS.
